

Required Seminars for Cases Involving Children

All parents <u>must</u> attend a <u>required</u> four hour seminar if there are children involved in the case. These seminars are required, even if the divorce is uncontested. These seminars may also be Required by the court in modification cases involving child custody, visitation or adoptions. The judge will not grant a divorce if both parents have not attended one of these classes. You can meet this seminar requirement by attending any of the classes listed below. All of these seminars require a fee at registration.
